#### SECTION 1

#### CONVENING

Empresa Pública Tame Línea Aérea Del Ecuador TAME EP "En Liquidación" convenes legal and natural people legally able that may be interested in the goods to be sold, that are domiciled nationwide or abroad; to present their bids for the NATIONAL AND INTERNATIONAL FAILED DIRECT PUBLIC SALE PROCESS OF AIRCRAFT OF TAME EP "EN LIQUIDACIÓN".

The terms of this convening are the following:

- The convening and other enabler documents of this process of direct failed aircraft's sale off, will be published and will be available, at no cost, on the institutional website of TAME EP "En Liquidación", <u>www.tame.com.ec</u>.
- 2. The bids must be addressed to the Chairman of The Sales Board of TAME EP "En Liquidación", physically at The Sales Board Secretary, located at The Legal Management, of the company TAME EP "En Liquidación", in the city of Quito, on Amazonas N24-260 and Colon Avenue, sixth floor, until Ecuador's local day and time, specified in the timeline of this process; besides, it will be possible to present the bids' offers to the institutional e-mail address: <u>aeronaves@tame.com.ec</u>.
- 3. Interested people will be able to make questions and schedule visits to the aircraft, to the e-mail address <u>aeronaves@tame.com.ec</u>; the Sales Board will process them through the previously mentioned e-mail address, in accordance to the timeline of this process.
- **4.** The bids must be handed attaching the certified check or the bank transfer receipt to the accounts of TAME EP "En Liquidación" for the whole value of the bid, which won't be less of the 100% of the base price or the appraisal price (announced base price).
- **5.** The evaluation of bids will be carried out with the methodology "complies/does not comply"; prioritizing the delivery order of bids.
- 6. Foreign bidders, who are abroad, or in case of not having a legal representation in Ecuador, or not having an electronic signature (digital), should assign a proxy in Ecuador, completely able to sign the contract and assume the obligations that may derive directly or indirectly, being these administrative or court order, in accordance of the provisions in the article 6 of the Ecuador's Company Law.
- 7. The aircraft, matter of this convening have all the enabling documents and previously to the adjudication, TAME EP "EN LIQUIDACIÓN", will update the encumbrances certification, emitted by the Aeronautical Recorder of the Dirección General de Aviación Civil Ecuatoriana.
- 8. The company TAME EP "EN LIQUIDACIÓN" reserves the right to declare the sale process void in case of no bids for any aircraft; or, supported by unfavorable reasons, may these be: economical, technical, legal, fortuitous event, or other nature event, in accordance with what is indicated in these conditions, situation that will not give rise to claims or compensations
